# Ryan White HIV/AIDS CARE Act (Law)

Congress passed the Ryan White CARE Act, in August of 1990, which improves access and the quality of healthcare for people living with HIV/AIDS. Today, the CARE Act continues to support health and social programs for people living with HIV/AIDS across the U.S.

This act was named for **Ryan White**, a teenager from Indiana. As a person living with HIV, Ryan White became a public figure and advocate for HIV/AIDS awareness, when there was much fear and misjudging about the disease.

# What is the NH CARE Program?

The NH Ryan White CARE program, a recipient of the federal Ryan White CARE Act Part B grant, has served NH residents living with HIV/AIDS for 30 years.

The program's goal is to improve client health through access to high-quality services.

The CARE program offers eligible NH residents living with HIV/AIDS access to healthcare and support services.

The NH CARE program shares the National 'Ending the HIV Epidemic' goals of:

- · Preventing new cases of HIV,
- Improving HIV-related health outcomes, and
- Reducing health disparities and inequities through combined prevention and care efforts.



### Am I Eligible?

To be eligible for the NH CARE program a person must:

- Be living with HIV,
- · Be a New Hampshire resident, and
- Have an annual household income at or below 500% of the Federal Poverty Level.

The NH CARE program is the payer of last resort. This means if you have insurance, your insurance must pay first. If you are uninsured, the NH CARE program can help you obtain insurance coverage.

The NH CARE program works closely with contracted case management agencies across New Hampshire who assist clients with enrollment in the program. Contact an agency near you to schedule an appointment with a case manager, and enroll in the NH CARE program.

Yes! Clients must recertify for the NH CARE program every six (6) months. Your case manager will assist with this process before the end of your six month period. This will ensure your benefits continue nonstop. This is an important step to maintain your access to care.
